Overview:

The Bees by the Blacksmith Shop has been a very successful partnership since it was created in June 2021. We've held numerous youth bee education classes as well as Bellingham Senior Living programs. The department is interested in adding bee hives to the Supplee Valley Open Space on Reservoir Road, given the success of our current installation. Bees are an extremely important part of our natural world. In fact, bees touch over 60% of all the food we eat. With their natural habitats under constant tension, it is important to provide habitat for pollinating insects where possible.

Location:

Supple Valley Open Space is located off Reservoir Road nearing the corner with E. Strasburg Road and is 26.1 acres of passive park space dotted by a creek, native plantings and an internal grass path. There is parking for 4-5 cars, but most usage comes from the connected neighborhoods.

This location is proposed because it's a large, Township owned park space created by the Conservancy Board that does not get significant usage.



Proposal:

- Add 4-6 bee hives that would be consistent with the size/scope of the Bees by the Blacksmith installation.
- Carmen B's Honey would manage and maintain the hives.

Benefits to Township:

- Provide honey bee habitat
- Improve the ecology and pollination of 26.1 acres of native plantings. Honeybees can travel up to 3.0 miles to find flowers, so this could also positively contribute to 37.0 acres of connected park open space.
- Study the effects on native plant health (size, pollination frequency etc.) over a distinct period. Could be a WCU or East HS student project.

Formal relationship:

- 1. East Goshen Township to provide the public space for this project. Carmen B's Honey will retain ownership/liability for the beehives and incur all costs associated with the bee hives during the duration of their placement.
- 2. The Township and Carmen B's Honey will sign a hold harmless agreement similar to our current partnership. The Township will not be held responsible for any expenses incurred should the hives be damaged or vandalized, for colony collapse or any other apiary-related activities.
- 3. One safety sign will be erected around the hives.
- 4. Maintenance Carmen B's Honey will perform all routine maintenance.
- 5. As specified in the contract, the Township can dissolve the relationship and ask that the hives be removed except between the specific months of April-July (removed in late August). The contract will be evaluated on an annual basis.

Similar local, current partnerships:

Carmen B's Honey currently has 13 hives at the Willistown Trust Preserve's 55 acre Ashbridge Preserve that is similar in park setting and visitor attendance.

Access:

Carmen B's Honey asks to be able to drive his vehicle close to the hive location as depicted on the graphic. The path leading to the hives, where he would drive, will not be improved with mulch or similar.



Distinct from Bees by the Blacksmith Shop (BBS) installation:

• This project will be different from the BBS installation in that its focus is on providing honeybee habitat and improving Township park ecological health. Given the proposed placement and lack of parking, it would not likely be used for Township class/demonstration purposes.

Motion:

I recommend placing beehives in the Supplee Valley open space in partnership with Carmen B's Honey.
