2. Camp Out – Jason reviewed the map for this year. Last year there were 100 tents and the event was a huge success. This year there will be 200 tents and 2 different movies. They will have silent disco in the pavilion with headsets for the participants to hear the music. Tickets will be \$65.00. Registration starts on March 1st for township residents and March 8th for nonresidents.
3. Collette Trips – Jason reviewed the past trips that the Township residents have gone on. In fall of 2024 the trip will be to Napa Valley in California. For late April in 2025 he gave London and Ireland as suggestions. Ireland was the most popular. In fall of 2025 the trip will be from New Orleans to Nashville.
4. Pickleball Tournament – On May 18, 2024 Jason is planning to have a Pickleball State High School Championship. He has contacted other Recreation Directors about this event. Our Tennis instructor, Justin, and two other instructors will assist. A cost has not been decided yet. The FOEG will supply limited travel vouchers for those traveling from other parts of the state.
