**NEW BUSINESS**

1. Eagle Scout Project Proposal - Conrad J. Kawalski II, Scout in Troop 93, 9<sup>th</sup> grade student at East High School, gave a presentation to put bat houses in East Goshen Park. He explained that the Little Brown Bat is endangered due to white nose syndrome. He will build 3 triple chamber bat houses which can hold up to 200 bats. He pointed out the locations in the park. They are ¼ mile away from water and facing south. He showed the timeline for installation which he estimated will be 60 – 100 hours. Home Depot will drop off the supplies. His uncle will use the auger to dig the holes. He created a QR code that, when scanned, will present information about the bats. Joe tried it and it was very good. His theme is “if you build it, they will come”. Jason and the Commission members thanked Conrad for the excellent presentation.

Discussion after Conrad left the meeting - Jason commented that usually for these projects the Commission gives a donation of \$200.00 and a plaque on completion. Ann Marie moved to approve Conrad’s bat house project and give the \$200.00 donation and the plaque. Deborah seconded the motion. The motion passed unanimously.

2. Memorial Day Event – Jason mentioned that the BOS has requested this event. He met with the West Chester VFW. They do an event every year at 12 noon with about 30 people. So, our event will be held on Monday May 27 at 2:00 pm at the main entrance to East Goshen Park. There will be bagpipes, then a welcome from Jason and a BOS. Then the VFW will do the flag and bugle ceremony which will take about 30 minutes. There will be some refreshments at the Hicks Pavilion. Commission members discussed a bike parade and gold star family.

1 3. ABC Planning Meeting - This meeting will be held on Tuesday March 12 at 6:00 pm. Jason reviewed the  
2 Accomplishments for 2023 and the Goals for 2024. Everyone agreed with his reports.

4 4. East Goshen Park Bathrooms – The Veterans bathrooms are usually closed during the winter but were open this  
5 year due to renovation of the Hicks bathrooms. After the renovation was done, the water well pump broke so both  
6 bathrooms had to be closed.

8 5. East Goshen Park Camp Out – So far 80 residents have signed up for this event. Registration will be open to the  
9 public tomorrow. Jason had 100 families last year and hopes to have 200 this year.
