Mary asked about continuing to talk to businesses about the resolution on plastic bags, straws and Styrofoam. Tony stated he does not see the resolution being used by the companies that he visited. If members of the Council desire to visit more to promote the resolution, he is not opposed to it but does not feel that it will work.

Kennan identified that we should be looking into water quality. A baseline should be established to measure against in the future.

Other items that were brought up: recycling bags at grocery stores, composting at school, yard waste and the native plant signage.
