- C) All signs to be constructed with hi-intensity sheeting.
- D) General:
  - 1) Performance bond or certified check for 50% of the contracted price must be supplied within 30 days after notification of the award of the contract.
  - All hardware to be supplied with breakaway posts.
  - 3) Unit prices to include all shipping and delivery charges.

    - o **First offense:** A written warning will be sent to the contractor.
    - Second through fifth offense: The price paid shall for the order shall be reduced by ten (10) percent.
    - Sixth offense: Contract will be terminated for non-performance.
    - Any damages assessed for any of the aforesaid violations shall be deducted from the next payment due to the Contractor.
