CALL TO ORDER/PLEDGE OF ALLEGIANCE

Karen called the meeting to order at 7 pm.

CHAIRMAN'S REPORT

None

NEW BUSINESS

1. Dog Park Jason received a letter from a former resident asking for consideration of a dog park. In the Park Master Plan in 2014, this was considered but again there was no interest. Jason will respond.

2. Ping Pong Parkinson Program - Jason reported that we have received a \$1,000 PPF Grant for the Ping Pong Parkinson Program so he can purchase two more tables which equals four so far. He will be at the National Conference and will do a session on this program.

3. Red White and Blue Sports Program - Jason wants to create a program for adults with different political viewpoints to find common ground and shared interest among sports, programs and activities. The Red White and Blue signifies R = Republican, W = Independent/other parties, and Blue = Democrats. However, we would not ask for party affiliation, voting records or any similar information. There will be one weeknight meeting per week. 6:30 to 7:30 pm. Options would be: Pickleball, Bocce, basketball, kickball, wiffleball, Ping Pong and Ultimate Frisbee among others. Registrants would be divided up indiscriminately during each program date and include no dialogue about politics. Karen made a motion to recommend the Red, White and Blue Sports Program move to the BOS for further consideration. Kishor seconded the motion. The motion passed unanimously.

1 4. East Goshen Park and Recreation on the Go - Jason commented that, while East Goshen Parks & Recreation
2 does many things well, one area of improvement is expanding recreational opportunities closer to our residential
3 neighborhoods. Currently, most of our programs and events only take place in EGT Park or the Township
4 Building. The Township does have many more public park spaces within our neighborhoods where we can
5 introduce “walkup” events. There are many other communities across PA that do something similar. We would
6 call it our “Parks and Rec on the Go”. It would take place in public spaces such as, Marydell Pond, Bow Tree
7 Pond, Grand Oak Open Space, Milltown Playground, etc. It will be offered once a month April – October,
8 6 – 7:30 pm in a different space each month. The proposed budget of \$500 would be an addition to the 2026 PR
9 general operating budget. The \$500 would be used to stencil the new PR logo and “on the go” on the sides of the
10 PR trailer. We propose rolling out a “video challenge” where neighborhoods would pitch why they should be the
11 first “on the go” neighborhood visit. Jessica moved to recommend the “Parks and Rec on the Go” program move to
12 the BOS for 2026 general fund budget consideration. Karen seconded the motion. The motion passed
13 unanimously.

15 5. Pickleball Courts Sponsorships - Jason has had conversations with people who would be interested in
16 sponsoring use of the courts. The revenue can be used to purchase new racquet sport equipment and maintenance.
17 The Friends of East Goshen (501c3) would be our sponsorship package partner. Sponsors would donate to FOEG
18 and would be able to hang a banner on the courts for a period of time. For \$1,000 a sponsor banner would be hung
19 for one year. The sponsor provides the banner max size of 4’ x 8’. All banners need to be Township approved.
20 Also, for \$500 the banner would be hung during summer months of May – September. The banners would be hung
21 facing the inside of the courts. Jessica moved to recommend the pickleball courts sponsorship program move to the
22 BOS for consideration. Kishor seconded the motion. The motion passed unanimously.

24 6. Art Walk - The Art Walk will be held Saturday September 27 and can be moved to Rustin High School if
25 weather is bad.

27 7. Camp Out and Pumpkin Festival - These events will be held on the same day.

29 8. Veterans Day and Neighbor to Neighbor Day - these events will be held on the same day. The Veterans Day
30 event will be at the EG park at 10 am. Then Neighbor to Neighbor Day will be after it.
