EMS calls were lower than average in September but YTD calls are still running 1% ahead of 2024, primarily due to call volume increases in East Goshen, Willistown and mutual aid responses.

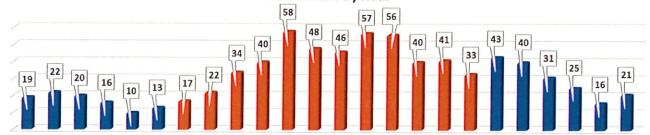

Call Volume By Day of Week

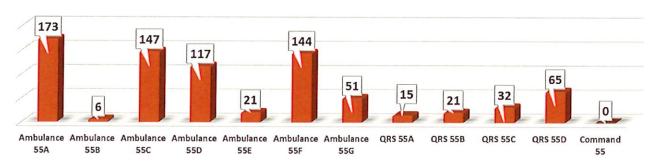


Call Volume By Hour

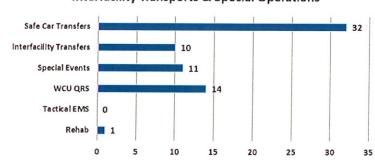


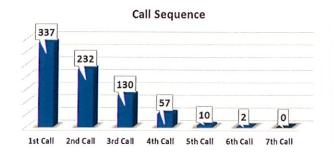

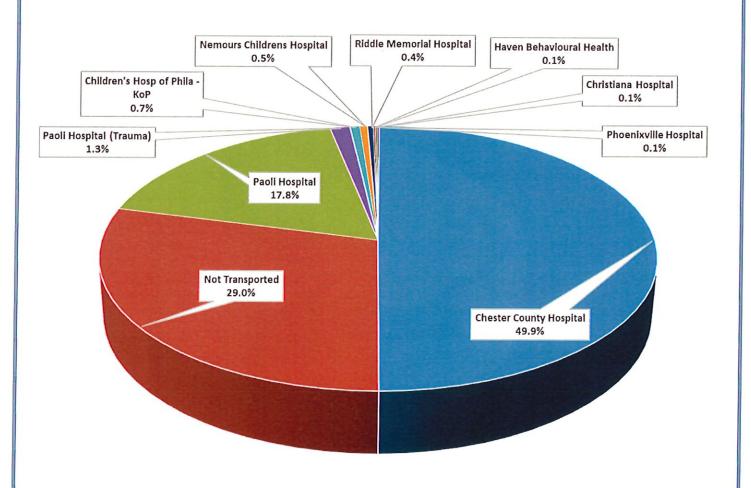

Date: September 21, 2025

As of September 30th, net of pass-thru, the general fund had YTD revenues of \$10,519,520 and expenses of \$9,257,789 for a net result of \$1,261,730. At the end of September, the general fund balance was \$7,741,480.

Budget:

YTD September revenue finished flat with budget. Shortfalls in Building Permits & the timing of engineering recharges were offset by alarm fees.

YTD September expenses are 0.6%, or \$58K, over budget. Legal land development fees, increased utility costs and the winter weather earlier in the year account for the variance.

Prior Year:

2025 YTD August Net Operations are \$215K below prior year driven by lower interest income and higher snow removal, paving and stormwater expenses.

Other funds

- The State Liquid Fuels Fund had \$539,847 in revenues and \$0 in expenses. The fund balance is \$541,068.
- The Capital Reserve Fund had \$120,704 in revenues and \$944,450 in expenses. The fund balance is \$4,737,873.
- The **Transportation Fund** had \$17,356 in revenues and \$5,723 in expenses. The fund balance is \$532,105.
- The **Sewer Operating Fund** had \$3,713,965 in revenues and \$3,156,270 in expenses. The fund balance is \$1,891,126.
- The **Refuse Fund** had \$1,035,126 in revenues and \$1124,460 in expenses. The fund balance is \$334,380.
- The **Bond Fund** had \$26,019 in revenues and \$263,069 in expenses. The fund balance is \$595,611.
- The **Sewer Capital Reserve Fund** had \$119,356 in revenues and \$432,141 in expenses. The fund balance is \$1,887,481.
- The **Operating Reserve Fund** had \$119 in revenues and \$0 in expenses. The fund balance is \$1,726,800.
- The ARPA Fund had \$723 in revenues and \$34,597 in expenses. The fund balance is \$3.
- The Infrastructure Sustainability Fund had \$224,156 in revenues and \$49,447 in expenses. The fund balance is \$1,568,395.

Attached please find the Treasurer's Report for the weeks of October 2, 2025- October 16, 2025.

Transfer Tax revenue, EIT collections, PURTA revenue, permits, alarm fees, and P&R registration fees drove General Fund revenue during this period.

General Fund expenses include the monthly WEGO contribution, vehicle maintenance/repairs, highway materials and equipment rental, stormwater materials and equipment rental, P&R programs and events, insurance payments, tree removal, and routine operational expenses.

Expenditures from the Capital Reserve Fund include \$10K for chipper payments (rent to own).

\$117K of Infrastructure Sustainability Fund expenses include \$110K for the relining of Linden Lane stormwater culvert as well as weed control for open spaces and the equipment rental for finishing the Bow Tree Pond project.

Re: West Chester Regional Emergency Response Team (WCRERT) Intermunicipal

Agreement

The West Chester Regional Emergency Response Team (WCRERT) is a specialized team made up of police officers from seven different agencies, covering nine municipalities in the greater West Chester area. Their role includes providing high level assistance in unique situations and functions as a regional "SWAT" team. East Goshen/WEGO is and has been part of this team for years.

Each year, all police departments contribute a certain amount in order for the team to function. Up until now, West Whiteland has been the fiduciary for WCRERT but no longer wants to stay in that role. Uwchlan Township has graciously offered to assume the role of fiduciary and be responsible for the funds. Overall, it is not a large amount of funding (\$5,000 per municipality right now but ours is done through the WEGO budget). However, with the switch of fiduciary, this was also an opportunity to codify this intermunicipal relationship, something that had yet to take place.

So, the proposed agreement and resolution are attached. It's important to note that this team has been functioning for quite a while and we have already been contributing to it. Nothing is proposed to change from a practical standpoint, only that Uwchlan will now host the funds.

We could take a look at tweaks to this agreement as time goes on if we all think it will be helpful but, to assist Uwchlan and West Whiteland from an auditing perspective, it was their hope we could get this in place before the end of the year. I believe four municipalities have already signed it.

DRAFT MOTION: Mr. Chairman, I move we pass Resolution 2025-09, allowing East Goshen to formally participate in the West Chester Regional Emergency Response Team and requesting that the Westtown-East Goshen Police Commission take the necessary steps to formally participate as well.

EAST GOSHEN TOWNSHIP CHESTER COUNTY, PENNSYLVANIA

A RESOLUTION OF THE BOARD OF SUPERVISORS OF EAST GOSHEN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA, TO ENTER INTO THE WEST CHESTER AREA REGIONAL EMERGENCY RESPONSE TEAM MUTUAL AID AND INTERGOVERNMENTAL COOPERATION AGREEMENT

WHEREAS, pursuant to 42 Pa.C.S. § 8953 entitled Statewide Municipal Police Jurisdiction, subsection (e) (relating to police service agreements), 53 Pa.C.S. § 2303 of the General Local Government Code (relating to intergovernmental cooperation authorized), 53 P.S. §§ 66903 and 66903 of the Second Class Township Code (relating to contracts to secure and provide police services), and 8 Pa.C.S.A. §1122 of the Borough Code, it is the desire of East Bradford Township, East Goshen Township, West Chester Borough, West Goshen Township, West Whiteland Township, Westtown Township, Willistown Township, Uwchlan Township, and the Westtown-East Goshen Police Commission (acting independently and on behalf of East Goshen Township and Westtown Township) and the aforementioned municipality's respective police departments to enter into a mutual aid agreement for the purpose of mutual aid and protection of life and property in the event of a situation which exceeds the equipment and personnel requirements of each individual municipality or police department; and,

WHEREAS, the municipalities who are signatories thereto, and the police departments within said municipalities, desire to reduce their mutual aid agreement to a cooperative agreement titled the "West Chester Area Regional Emergency Response Team Mutual Aid and Intergovernmental Cooperation Agreement" (the "Agreement"), to which the municipalities will be parties, a copy of which is attached hereto as Exhibit "A"; and,

WHEREAS, East Goshen Township and Westtown Township have also entered into the Westtown East Goshen Police Agreement dated December 7, 2020 (the "WEGO Police Agreement") establishing the Westtown-East Goshen Regional Police Department as an unincorporated association providing police protection to East Goshen Township and Westtown Township; and

WHEREAS, the WEGO Police Agreement created the Westtown-East Goshen Regional Police Commission as a legally independent unincorporated and nonprofit association to be the governing body of the Westtown-East Goshen Regional Police Department.

NOW THEREFORE BE IT RESOLVED, that the East Goshen Township Board of Supervisors desires to approve the Agreement with the other municipalities and police department identified above so that they may render unto each other, on a mutual aid basis, such police

assistance, police services or other emergency services within the corporate limits of each of said municipalities that have adopted or endorsed cooperative agreement, upon the terms and conditions set forth therein, which terms and conditions are incorporated herein by reference.

BE IT FURTHER RESOLVED, that the East Goshen Township Board of Supervisors authorizes the Westtown-East Goshen Regional Police Commission to take the necessary steps to approve the Agreement and carry out the provisions of the Agreement in compliance with the purposes and intent of the Agreement.

WEST CHESTER AREA REGIONAL EMERGENCY RESPONSE TEAM MUTUAL AID AND INTERGOVERNMENTAL COOPERATION AGREEMENT

THIS AGREEMENT ("Agreement"), made and entered into the day of
, 202, among the following municipalities, all of which are political
subdivisions of the Commonwealth of Pennsylvania or intergovernmental entities created
pursuant to the Intergovernmental Cooperation Act, by their duly elected Board of Supervisors,
Borough Councils, and Governing Executives, or duly appointed Commissions: East Bradford
Township, East Goshen Township, West Chester Borough, West Goshen Township, West
Whiteland Township, Westtown Township, Willistown Township, Uwchlan Township, and the
Westtown-East Goshen Police Commission (the latter acting on behalf of East Goshen Township
and Westtown Township), (hereafter collectively referred to as the "Political Subdivisions" or
"Parties").

WHEREAS, Pursuant to Title 42, Section 8953, subsection A, entitled "Statewide Municipal Police Jurisdiction" (hereinafter the "Code"), it is the desire of various municipalities and police departments within said municipalities to form a mutual-aid agreement for the purpose of mutual police and emergency protection; and

WHEREAS, Pursuant to Title 53, Section 2301, et seq, entitled "Intergovernmental Cooperation" (hereinafter the "Cooperation Law"; the Code and the Cooperation Law are hereinafter referenced collectively as "State Law") authorizes political subdivisions to enter into joint agreements deemed appropriate to jointly cooperate in the exercise or in the performance of their respective governmental functions, powers, or responsibilities; and

WHEREAS, the Parties recognize that the people and communities within their jurisdictional boundary are vulnerable to crime, injury, loss of life, and other situations which may exceed the equipment and personnel requirements of each individual Party; and

WHEREAS, the governing officials of the Parties desire to secure for each Party the benefits of mutual aid and protection of life and property in the event of a situation which exceeds the equipment and personnel requirements of each individual Party; and

WHEREAS, the Parties wish to provide for a trained tactical unit to respond to such critical incidents and preserve life, and are so authorized to make this Agreement pursuant to State Law.

NOW, THEREFORE, WITNESSTH, that, for and in consideration of mutual promises and agreements contained herein, the Political Subdivisions hereby agree as follows:

1. The above is expressly incorporated herein as material part of the Agreement.

Creation and Management of the West Chester Regional Emergency Response Team by an Executive Board

- 2. The Political Subdivisions hereto do hereby create the West Chester Regional Emergency Response Team (hereinafter the "WCRERT").
- 3. The mission of the WCRERT is to provide a trained tactical unit to respond to critical incidents and preserve life.
- 4. WCRERT shall be governed by an executive board of six (6) members, consisting of the Police Chief from each of the Political Subdivisions (hereinafter the "Board"). Any member may designate in writing a qualified representative to serve and vote in that member's stead. In the event a Political Subdivision participates in a regional police department or contract for service from another police department, the Police Chief of said police department will represent that Political Subdivision.
- 5. The Board shall establish, by majority vote, certain policies to carry out the mission of the WCRERT (hereinafter "Policies & Procedures").
- 6. All decisions of the Board, as specified in this Agreement and in the policies and procedures developed and approved by the Board, shall be determined by a simple majority vote of the Board.

- 7. The Board may appoint a team leader to assist in the oversight and operations of the WCRERT and any agents or contractors appointed by the Board.
- 8. The Board shall prepare and submit an annual report to each Political Subdivision that is a party of this Agreement. The report shall be delivered no later than March 31 of each calendar year and shall cover the preceding calendar year. The annual report shall include, at a minimum: a summary of team activities and deployments; training exercises and certifications; budget and financial expenditures; member participation and staffing levels; and any significant operational developments or strategic initiatives. The report shall be submitted in writing to the governing body of each Political Subdivision and may be provided electronically unless a hard copy is specifically requested.

Management of the WCRERT through an Agent

- 9. A Political Subdivision party to this Agreement shall serve as an agent (hereinafter the "Agent") to manage, through the WCRERT Team Leader and Board, the programmatic, financial, and grant-related activities of the WCRERT in accordance with State Law and policies set by the Board.
- 10. The Board is authorized to enter into a separate agreement with Agent detailing roles and responsibilities.
- 11. The Agent shall establish a special interest-bearing account for the WCRERT to carry out the mission of the WCRERT and its responsibilities as the Agent.
- 12. The WCRERT shall follow the procurement policies and procedures of the Agent.
- 13. The Agent shall conduct an annual financial audit in accordance with auditing standards generally accepted in the United States of America (GAAS) and the standards applicable to financial audits contained in *Governing Auditing Standards*, issued by the Comptroller General of the United States of America (*Government Auditing Standards*). The annual audit must be completed and provided to each Political Subdivision party to this Agreement no later than 180 days after the Agent's fiscal year ends. The Board may set additional policies or guidelines for the audit.
- 14. The auditor of any participating Political Subdivision may audit the finances of the WCRERT.

- 15. The Political Subdivisions shall cooperate with the Agent in a timely manner in providing programmatic, financial, and other grant-related information consistent with Operating Policies.
- 16. Grants to an individual Political Subdivision, regardless of the source, are not part of the contemplated funding of WCRERT under this Agreement.
- 17. The location of facilities and equipment to support the mission of the WCRERT shall be determined by a majority vote of the Board.

Membership in WCRERT

- 18. The Police Departments of the Parties are automatically members of the WCRERT (hereinafter "Jurisdictional Members") and agree to comply with the provisions of this Agreement.
- 19. Other Law Enforcement agencies are eligible to become members of the WCRERT (hereinafter "Other Members") provided they satisfy the requirements of this section on Membership and otherwise comply the provisions of this Agreement.
- 20. Jurisdictional Members and Other Members agree to assign one or more Act 120 Certified Police Officers which meet the qualifications established by the Board (hereinafter "Assigned Officer" or "Assigned Officers") to the WCRERT.
- 21. Jurisdictional Members and Other Members must agree to render, on a mutual aid basis, in response to a duly authorized request, such police assistance or other emergency services as shall be requested or required within the corporate limits of the Parties, subject to conditions and limitations hereinafter set forth.
- 22. Assigned Officers will train and work as set forth in policies and procedures developed and approved by the Board.
- 23. Assigned Officers shall remain employees of their Police Department in which their employment originated.
- 24. Any financial compensation of Assigned Officers is the responsibility of the Assigned Officer's employing municipality.
- 25. All health care benefits will be the responsibility of the Assigned Officer's employing municipality.

- 26. Any injury received while responding to, attending, or returning from activation, whether training or actual, will be considered work-related and will fall under the provisions of the injured Assigned Officer's respective employer's collective bargaining agreement. The employer shall provide workers' compensation coverage for all Assigned Officers during these activities, ensuring compliance with the Pennsylvania Workers' Compensation Act.
- 27. Nothing herein is intended nor shall be construed to violate the undersigned municipalities' collective bargaining agreements. Any conflict between this Agreement and a municipality's applicable collective bargaining agreement shall be governed by the collective bargaining agreement.
- 28. Jurisdictional Members and Other Members will make every reasonable effort to ensure their Assigned Officer or Assigned Officers attend any and all training as directed by the WCRERT.
- 29. Jurisdictional Members and Other Members agree that the Assigned Officer or Assigned Officers will be subject to and comply with the command structure of the WCRERT.
- 30. Jurisdictional Members and Other Members agree that they will supply all needed and necessary equipment to the Assigned Officers assigned to the WCRERT.
- 31. Jurisdictional Members and Other Members agree that they will pay an annual membership fee of up to \$25,000 as set by the Board to be used to purchase training and equipment for use by the WCRERT and the Assigned Officers.
- 32. Jurisdictional Members and Other Members agree they will carry General Liability, Auto Liability, Auto Physical Damage, Police Professional Liability, and Public Officials and Employment Practices Liability coverages in amounts determined to be sufficient by the Board. The Board may not set coverages less than the following amounts:
 - a. General Liability: \$1,000,000 per occurrence / \$2,000,000 aggregate
 - b. Auto Liability: \$1,000,000 combined single limit
 - c. Police Professional Liability: \$1,000,000 per claim / \$1,000,000 aggregate
 - d. Public Officials and Employment Practices Liability: \$1,000,000 per claim /
 \$1,000,000 aggregate
- 33. Jurisdictional Members and Other Members agree they will defend themselves, at their own cost, in any action related to this Agreement, any action related to WCRERT's

provision of service, and any action involving their Assigned Officer or Assigned Officers.

Term

34. This Agreement shall continue in force and remain binding on each participating Political Subdivision for one year with an automatic renewal for additional one-year terms on the execution date of the Agreement, unless and until the governing body of a participating Political Subdivision shall take action to withdraw from the Agreement. Such action shall not be effective until thirty (30) days after written notice of withdrawal has been sent by the Political Subdivision desiring to withdraw to the other participating Political Subdivisions to this Agreement.

Notices shall be deemed given when received if given in person, by facsimile or by electronic means (if a record of receipt is kept by the sending party showing the date and time of receipt) or three (3) days following deposit in the United States Mail, postage prepaid, to the addresses set forth above.
- 37. Any Political Subdivision may change its contact individual and/or address for notice by giving written notice of the change to the other Political Subdivisions and the Agent of the WCRERT.

Miscellaneous

- 38. This is a complete agreement and supersedes all previous Agreements.
- 39. This Agreement shall become effective immediately upon its execution by all Parties.

40. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

Municipal Funding Request for Fire and Emergency Medical Services (EMS)

Dear Supervisors,

I am writing on behalf of Malvern Fire Company, one of the primary providers of fire protection and basic life support (BLS) and advanced life support (ALS) pre-hospital emergency medical care to the residents and visitors of East Goshen Township. We respectfully submit this request for financial support from the Township in the amount of \$150,000 for the fiscal year 2026, to maintain and improve the quality of fire and emergency medical services provided to our community. We recognize that this request is a significant increase from years past and would welcome the opportunity to discuss this request further in person, in the hopes of developing a mutually beneficial, tiered approach to be fully funded no later than the 2028 budget.

Background

Since its establishment in 1888, Malvern Fire Company has proudly served the residents and visitors of the Great Valley region. In 1998, as the landscape of advanced life support began to transition away from hospital-based responders, Malvern Fire Company stepped up to the challenge and was the first fire department-based ALS service in Chester County. Our team of highly trained firefighters, emergency medical technicians (EMTs), and paramedics provide critical, life-saving services 24 hours a day, 365 days a year, responding to over 2,100 emergency medical calls and over 350 fire-related emergencies annually, with approximately 400 EMS responses and 20 fire responses within East Goshen Township each year.

Financial Background

As you are likely aware, volunteerism continues to dwindle across the country, and locally the trends are no different. Despite the hard work of the dedicated volunteers to participate in fundraising activities, we have reached a point where those fundraising activities do not offset the rising costs of vehicles, medical equipment/consumables, and personnel costs. While we do recoup a portion of our expenditures with revenue from EMS billing, subscription/fund drives, and our annual fair fundraiser, the Malvern Fire Company has unfortunately barely broken even for several years, at times operating in the negative. This breakeven status has made saving for future capital expenditures challenging at best. We have compiled data looking at a combination of factors including revenue, expenditures, municipality-based call volume broken down by fire

and EMS responses, as well as a proposed capital savings plan in order to more accurately request funds from the municipalities we serve.

Justification for Funding

Due to increasing costs related to personnel, supplies, equipment and vehicles, we are seeking increased municipal support to help offset these rising costs.

- Equipment Needs: Our five (5) cardiac monitors are reaching the end of their recommended life cycle and will require replacement to meet current safety and performance standards. The cost of each cardiac monitor is currently around \$60,000, for a total replacement cost of \$300,000.
- Ambulance/Medic Responder Replacement: Our frontline paramedic responder unit has surpassed its life expectancy, leading to increased maintenance costs and reduced reliability. We are currently operating a 2013 Chevrolet Tahoe with over 110,000 miles. A replacement for this vehicle will cost approximately \$85,000. Additionally, we have a 2016 ambulance that is due for refurbishment in 2026 with an expected cost of approximately \$200,000.
- Personnel Costs: To ensure full staffing levels, we seek support to help offset wages and training costs in an increasingly competitive labor market. We currently staff a minimum of one EMT and one paramedic, many of whom are cross trained for both fire and EMS, 24 hours a day, 365 days a year, with an additional staff member Monday through Friday during daylight hours. In FY 2024, staffing costs were approximately \$920,000, accounting for 65% of our total operating expenses. Given the decline in volunteerism, we would like to augment our staff to include a fourth person Monday through Friday and a third person on the weekend during daylight hours, which is our peak volume at a cost of approximately \$200,000.

Requested Support

We respectfully request municipal funding in the amount of \$150,000, which will be allocated as follows:

Prepared by Howell Engineering, dated 1/18/2024, last revised 8/19/2025

The applicant proposes a 16-lot residential subdivision and associated improvements, with thirteen (13) lots located within West Whiteland Township, and three (3) lots located within East Goshen Township (identified as lots 6, 7, 8). The subdivision is within the R-2 Low Density Residential District and is permitted "by-right" in accordance with East Goshen Township Code §240.9.

The proposed cul-de-sac will be maintained by the residents and/or Homeowners' Association as a private road. Neither East Goshen nor West Whiteland will bear maintenance responsibilities.

Lots 6, 7 &8, located within East Goshen, will connect to West Whiteland's sewer facilities. West Whiteland will also provide municipal trash removal services for all homes in the Development.

Currently, West Whiteland imposes an annual Residential Sanitary Sewer Fee of \$285.00, an annual Recycling Fee of \$89, and administers a "pay-as-you-'throw" municipal trash service, funded by the purchase of township bags.

The applicant has requested that the Board grant the following waivers from the East Goshen Township Subdivision and Land Development Ordinance:

- 1. From §205-28 to allow for a concurrent preliminary/final plan review and approval process.
- 2. From §205-44.E to allow the construction of the proposed cul-de-sac without a the required ten-foot radius "green" center island.

East Goshen Township Fire Marshal, Duane Brady, and the East Goshen Planning Commission have recommended that the Board grant the waiver regarding the center island to provide additional area for the access and maneuvering of emergency vehicles/apparatus.

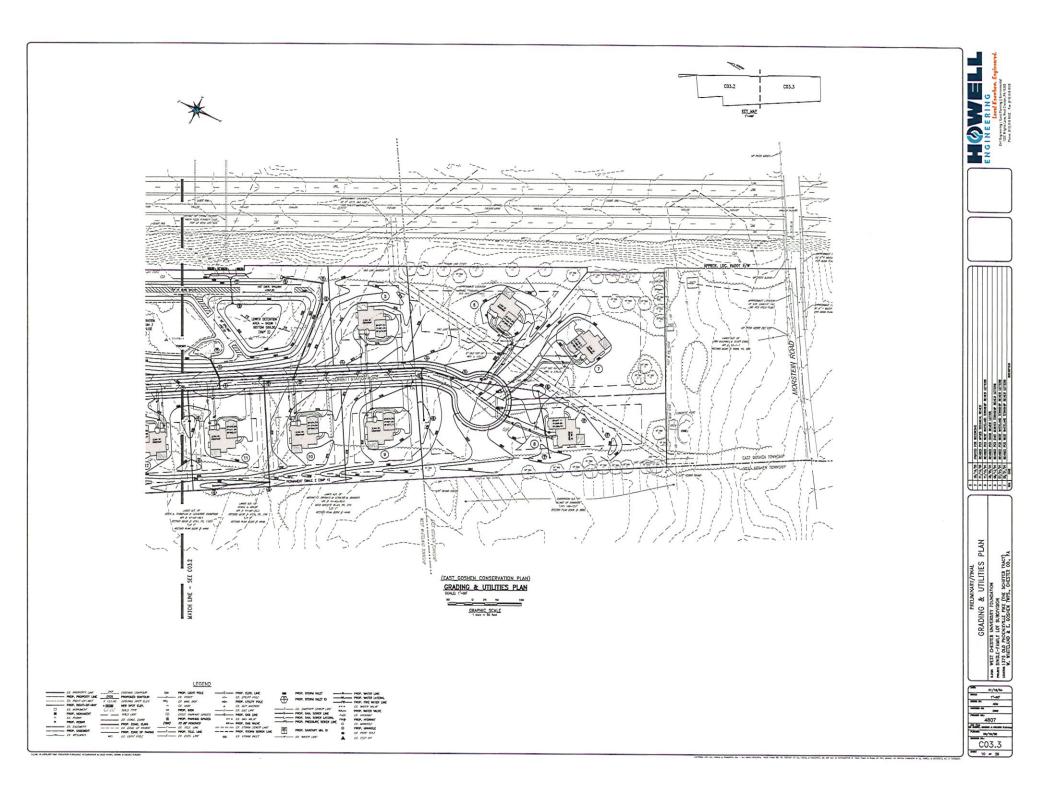

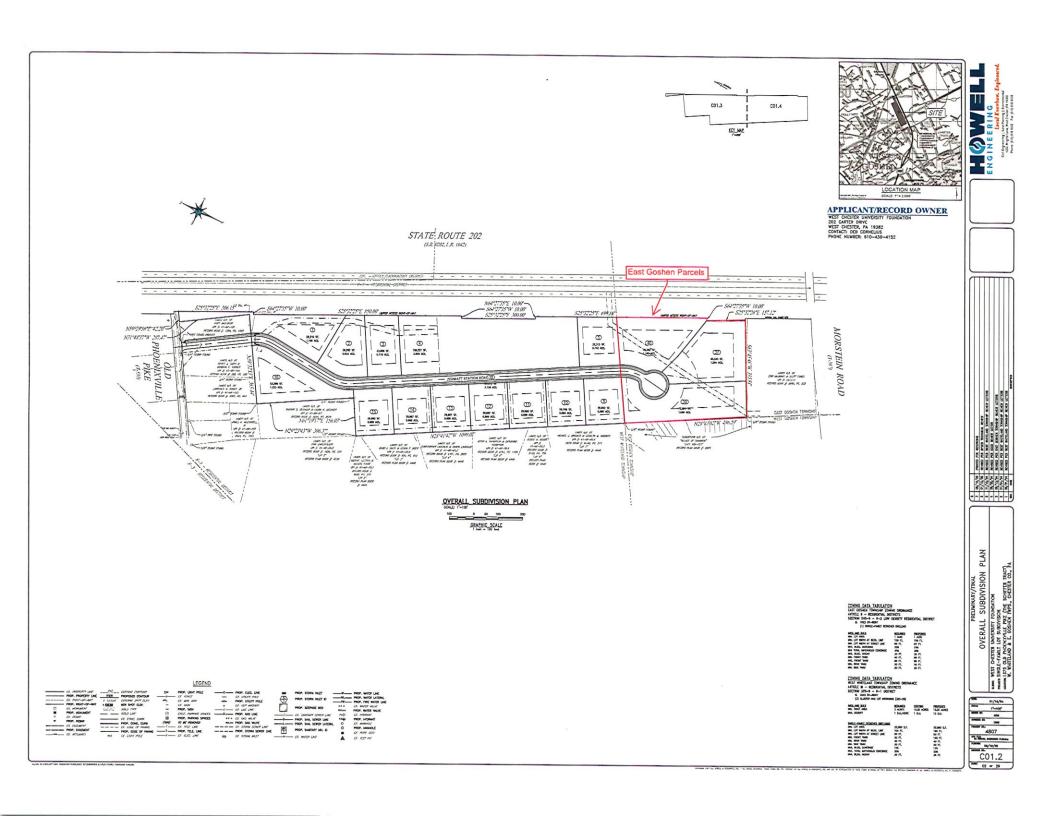
In addition, Mr. Brady recommends that the Board impose the following conditions of approval regarding the parcels located within East Goshen Township:

- 1. All driveways are required to be a minimum of 15 feet wide for fire apparatus access.
- 2. All new dwellings shall have a residential sprinkler system installed to provide additional fire protection in the absence of a secondary emergency egress, due to the configuration of the development, and the presence of the pipeline located through lots 6, 7, & 8.
- 3. The developer must provide written notice to the purchasers of lots 6, 7, and 8 regarding the location of the pipeline, and obtain an executed acknowledgment of receipt. A copy of the notice and receipt must be provided to the Fire Marshal prior to occupancy.

Draft Motion:

Mr. Chairman, I move that the Board of Supervisors approve the Prelimenary/Final Land Development Plan of 1375 Old Phoenixvelle Pike & 1338 Morstein Road for the West Chester University Foundation with the requested waivers granted, subject to the conditions recommended by the Township Fire Marshal, and addressing all comments outlined in the Township Engineer's review letter, dated October 15, 2025.

Preliminary/Final Subdivision and Land Development - 3rd Review

Dear Kelly:

As requested, we have reviewed the following information, prepared by Howell Engineering, regarding the referenced submission:

- "Preliminary/Final Subdivision and Land Development Plans of 1375 Old Phoenixville Pike and 1338 Morstein Road" (28 sheets) dated January 18, 2024, last revised August 19, 2025;
- "Stormwater Management Report" dated January 18, 2024, last revised July 24, 2024;
- "Pipeline Awareness Study" dated January 22, 2024;
- "Sewage Facilities Planning Module" dated December 18, 2023;
- · Application and supporting documents.

The applicant/equitable owner, West Chester University Foundation, proposes to subdivide UPI #41-6-88.1 (±15 acres) and #53-1-2.1 (±5 acres) into sixteen (16) lots: three (3) lots in East Goshen Township and 13 lots in West Whiteland Township. The existing house located on proposed Lot 3 is a Class 2 historical resource within East Goshen. The site is located north of the intersection of Morstein Road (T-387) and Killern Lane, within the R-2 Low Density Suburban Residential Zoning District. Access is proposed via Old Phoenixville Pike within West Whiteland Township. Both public water and sanitary sewer are proposed.

The applicant is requesting the following two (2) waivers:

- 1. From §205-28 to allow for a joint preliminary and final plan submission.
- 2. From §205-44.E to not require a center green island in the middle of the proposed cul-de-sac.

We offer the following comments (new comments in bold/italics):

ZONING (§240)

Minimum lot width at the building setback line shall be 150 feet and 60 feet at the street line. (§240-9.G) Lot 7
does not meet these requirements.

Resolved. The plan has been revised so that the building setback line is 150 feet wide.

SUBDIVISION AND LAND DEVELOPMENT (§205)

2. The plans are titles "preliminary/final". If this is a joint submission, a waiver should be requested from the requirements of a separate preliminary plan submission. (§205-28)

Resolved. A waiver request has been added to the cover sheet requesting a join submission.

- 3. Plans should include:
 - a. A list of trees proposed to be removed and trees proposed to be maintained. (§205-30.B(14))
 - b. Specifications for removal of trees. (§205-30.B(15))
 - c. Specifications for protection of existing trees that are to remain during construction, including grade changes or other work adjacent to the trees which would adversely affect the trees. (§205-30.B(16))

Resolved. Existing tree locations and tree protection fencing are now indicated.

4. Included with the plan submission shall be full documentation of any proposed homeowners' association, covenants or other such proposed association and/or restrictions governing the subdivision and/or land development. (§205-30.C(4)(i)) Notes on the plan reference a Homeowners Association. Required documentation shall be submitted to the Township for review by the Township Solicitor.

Pending. Draft HOA documents will be provided under separate cover prior to plan recording for review by the Township Solicitor.

5. A conservation plan should be submitted as part of the plan set and meet the requirements per §205-35.

Resolved. Adequate information is provided within the plan set.

6. As the proposed access is in West Whiteland, we recommend any traffic impact study requirements be deferred to West Whiteland Township.

Resolved. A traffic impact study assessment was provided to West Whiteland Township and reviewed by their traffic consultant.

7. A Pipeline Awareness Study has been submitted. (§205-40.1) Please see April 29, 2024 comments from the Pipeline Task Force.

Resolved. No plan revisions needed; the Pipeline Task Force stated in their email the study fully complies with this code section.

8. The length of a cul-de-sac shall be a maximum of 1,500 feet. Any proposed cul-de-sac longer than 1,500 feet long must be approved by the Township Supervisors upon recommendation of the Township Engineer. (§205-42.F) No emergency access is proposed.

Pending. The current length of the cul-de-sac is greater than 1,500 feet, but less than 1,500 within East Goshen Township. Defer to Township.

9. A cul-de-sac street is a minor street; the turnaround shall have a right-of-way diameter of 120 feet and the cartway paving width shall be 40 feet with a ten-foot radius center island. (§205-44.E) Turnaround cartway paving width is currently proposed at 30 feet with a 20 foot radius center island.

Resolved. Both the East Goshen and West Whiteland Fire Marshals have requested the removal of the center island. The island has been removed, and a waiver has been formally requested from this section.

10. All street names shall be subject to the approval of the Board of Supervisors, the Chester County Department Emergency Services and the postmaster. (§205-53.C) This should further be coordinated with West Whiteland Township.

Resolved. The proposed street name has been added to the plans.

11. In reviewing subdivision and land development plans, the Planning Commission shall consider whether community facilities...in the area are adequate to serve the needs of the additional dwellings proposed by the development. (§205-58)

Pending. No plan revision necessary; defer to Township.

STORMWATER MANAGEMENT

12. Submit the required NPDES permit. (§195-17.A(1)(b))

Resolved. An approved NPDES permit was provided.

13. It appears that no additional runoff created by this project in East Goshen Township is being managed within East Goshen Township. All of the stormwater runoff from East Goshen is piped or travels overland to be management in BMPs located in West Whiteland. Based upon this design, we defer technical review of the proposed public sewer system design to West Whiteland. Easement and/or maintenance agreements with West Whiteland may be required. (§195-19, §195-20, §195-21, §195-22)

Resolved. West Whiteland Township has approved the final plans and the stormwater design.

14. It appears that the runoff from Lot 6 discharges over land directly onto Lot 5. We recommend directing the runoff to the stormwater piping in the road right-of-way.

Resolved. The runoff from front yard Lot 6 is being directed to the lower detention basin.

15. Drainage easements for the stormwater piping and swales in Lots 6, 7, and 8 may be required.

Resolved. Drainage easements are provided for the major conveyance segments. Yard drains and smaller piping are considered private conveyance.

16. Include yard drains YDA, YDB & YDC in the profiles.

Resolved. Profiles are provided on sheet C05.3.

LANDSCAPING

17. Per aerial imagery, tree masses exist on the property. A tree survey will be required to determine if specimen trees (any tree greater than 12 inch caliper within a tree mass and greater than 6 inch caliper outside the tree mass, and any unique or rare species of tree greater than 4 inch caliper existing in any location) exist. All existing tree masses and specimen trees shall be noted and sufficiently labeled. (§205-36.E)

Resolved. The applicant has indicated all 12-inch caliper (or greater) trees and notes the remaining vegetation is overgrown meadow.

- 18. The plan states landscape compliance is "To be Determined" to the following code sections:
 - a. Preserving Existing Trees. (§205-61.A)
 - b. Preservation of Specimen Trees. (§205-61.B.(10))
 - c. No more that 20% of trees on a wooded lot may be removed. (§205-61.C.)
 - d. A maximum of 50% of the trees on a wooded lot may be removed if the requirements in subsections are meet. (§205-61.D)
 - e. Tree removed in excess of the 20% permitted shall be replaced on an inch for inch basis. (§205-61.D.(1))
 - f. The diameter breast height of the trees to be removed that are in excess of the 20% shall be determined. (§205-61.D.(2))

- g. All replacement trees shall be a minimum 3" caliper. (§205-61.D.(3))
- h. The total diameter of the replacement trees shall equal the DBH of the trees removed (§205-61.D.(4))

Once a tree survey of the property is completed, please address these Code sections.

Resolved. Additional existing tree information has been provided and the applicant has clarified that less than 20% of all trees will be removed within East Goshen Township.

19. Landscape buffers have not been provided on Lots 6 & 7 and the landscape requirements chart provided on Sheet 28 indicates "existing plant material to satisfy the requirement"; further detail is required on how the buffer requirement is being met. (§205-60.B(3)(a) & §205-60.B(3)(b))

Outstanding. In the previous response letter, the applicant indicated the existing vegetive cover meets the requirements of this section. However, this section requires a combination of evergreen trees no less than 8 feet in height and deciduous trees be used to create a "high-level screen"; please provide additional clarification this requirement has been adequately addressed.

20. Lot 8 has a buffer provided, however the plant material indicated does not tabulate to the required number of plants. (§205-60.B(3)(a) & §205-60.B(3)(b))

Outstanding. Sheet 29 indicated 44 shade and evergreen trees and 99 shrubs are provided. However, Sheet 28, indicates only 31 trees and 96 shrubs in the buffer.

21. The following note shall be added: "Care and maintenance of buffer yard, including plantings, shall be the sole responsibility of the property owner." (§205-60.H)

Resolved. The note has been added; see Sheet 26.

22. Street trees have been provided. Per the right-of-way and lot curve data provided on Sheet 4 there is 531.29 LF of right-of way; per this tabulation, 14 trees shall be provided. (§205-62)

Outstanding. It appears only 13 street trees are proposed within East Goshen Township.

23. Protection of existing trees to remain shall be provided. Currently the plans do not clarify how existing trees to remain will be protected. Plan notes, details, and the edge of the tree protection zone for trees be protected shall be shown on the plans. (§205-63)

Resolved. Existing tree locations and tree protection fencing are now indicated.

SANITARY SEWER

24. The end of the proposed low pressure force main crosses the municipal boundary to serve three lots (Lots 6, 7, and 8) that are located within East Goshen Township. We recommend that the entire proposed low pressure force main be owned and maintained by West Whiteland Township since only a small portion at the end of the line is in East Goshen, and the force main is an extension of the West Whiteland sewer system. Further, it is not practical for two different entities to maintain a pressure pipe. An intermunicipal agreement between West Whiteland and East Goshen Townships should thereby be established for West Whiteland to own and maintain the entire low pressure force main. We anticipate the terms of the agreement would stipulate that the three lots in East Goshen would be sanitary sewer customers of East Goshen with the sewer usage rate to be determined based on West Whiteland's sewer rates. East Goshen would collect sewer payments from those three customers, and West Whiteland would then bill East Goshen for the three customers' sanitary sewer usage. The grinder pumps and low pressure customer piping would all be privately owned for their entire length to their point of connection to the new public force main. Under this premise, we defer technical review of the proposed public sewer system design to West Whiteland.

Resolved.

25. East Goshen Township requires all simplex grinder pumps to have a spare pump on site. (§188-33.B(2)) This should be noted on the plans.

Resolved.

26. PADEP Sewage Facilities Planning exemption or approval shall be provided.

Resolved. The Chester County Health Department recommended approval of the Sewage Facilities Planning Module.

GENERAL

27. Parcel 53-1-2.1 within East Goshen Township does not appear to be indicated correctly. ChescoViews indicates a small portion of the parcel extending from Morstein Road to the property along the SR 202 right-of-way; please clarify.

Resolved. Per the applicant, ChescoViews is inaccurate and the small portion of Parcel 53-1-2.1 extending for Morstein Road no longer exists; it is likely that the Right-of-Way for SR 202 was modified and ChescoViews not updated.

28. It appears that the driveways and utilities for Lots 6 and 7 will need to cross the pipeline easement.

Resolved. The applicant submitted a letter dated February 3, 2025, indicating that Sunoco Pipeline L.P. has reviewed the drawings and has no objections to the work subject to various noted conditions.

29. In addition to sanitary sewer and stormwater considerations noted above, road maintenance, snow plowing, trash pickup and similar will need to be coordinated between both Townships.

Acknowledged.

30. Please see March 8, 2024 Chester County Planning Commission comments.

Acknowledged.

31. Proposed lots 6, 7, and 8 are incorrectly labeled as 40, 37, and 39 on Sheets 2 and 4.

NEW SANITARY SEWER COMMENTS

32. A note should be added to the plan indicating that West Whiteland will own and maintain the entire low pressure force main, and that the three lots in East Goshen are to be sanitary sewer customers of East Goshen. A note should also be added indicating that the grinder pumps and low pressure customer piping is to be privately owned for their entire length to their point of connection to the new public force main.

The applicant is reminded all easements, agreements (i.e., developer's agreement, stormwater management operations and maintenance agreement) or similar, as applicable and coordinated with West Whiteland Township, are required to be submitted to the Township and subject to review and approval by the Township Solicitor prior to recording.

The Township Fire Marshal has reviewed the Revised Subdivision Plans dated January 15, 2025, for the creation of a new 16 lot residential subdivision. The subdivision is split between West Whiteland Township and East Goshen Township with lots 6, 7, and 8 located in East Goshen Township. After completing the plan review the following recommendations and comments are provided:

Fire Hydrant location. The plan shows one new fire hydrant located across from lot 2, that was the only hydrant note on the plan. The IFC 2018 Edition pre section 507.5.1
 Where required Exceptions: one requires a fire hydrant within 600 feet of a Group R-3 Occupancy. Request that an additional fire hydrant be installed with 600 feet of the new Single-Family Dwelling located in East Goshen Township.

RESOLVED

2. Fire Hydrant Location. The plan did not note the area/location of any existing fire hydrants. Request that existing fire hydrant locations be marked on plans or note that no hydrants exist around the new development.

RESOLVED

- Fire Hydrant Location, Request the distance between all fire hydrants located in the new development and any existing hydrants be provided for review. RESOLVED
- Fire hydrant and fire flow rates were not provided to check for compliance with the IFC 2018 code requirements. Provide the flow rates for review.
 PENDING – Flow rates have not been provided but have been requested from Aqua.
- Fire hydrants will the newly installed system be private or public.
 RESOLVED Both fire hydrants are located within West Whiteland Township.

- 7. Provide the existing available fire flow rate to the development for review. **PENDING** Flow rates have not been provided but have been requested from Aqua.
- The development street/road shall meet the required apparatus turning requirements. As required in the IFC 2018 section 503.2 Specifications. Please provide a Fire Truck Pathway Plan showing the requirements will meet the code.
 RESOLVED
- The development street/road shall be installed to carry a minimum of 75,000 pounds as required for fire access roads in the IFC 2018 section 503,2.3 Surface. RESOLVED
- The development street/road shall be installed with a grade that does not exceed 10 percent in grade as required in the IFC 2018 section 503.2.7 Grade.
 RESOLVED
- 11. The development plans show an island in the center of the Cal-da-sac. Recommend that is be removed to allow for more room during emergency incidents.
 PENDING A waiver is needed from the Board of Supervisors.
- 12. The development plans do not show the width of the new driveways. Provide the width of all driveways. To confirm they meet the requirements of the IFC 2018 section 503 Fire Apparatus Access Roads.
 PENDING East Goshen Township Fire Marshal is asking the Board of Supervisors to require all driveways located in East Goshen to be a minimum of 15 feet wide for fire apparatus access.
- 13. The development plans show a pipeline running through lots 6, 7, 8 with no distances listed from the center of the easement to the building foundations. Request that the distances be added to the plans.
 RESOLVED
- 14. The development plans show a pipeline running through lots 6 and 7 in front of the new home. This will limit access or cut off access to the residents in case of an emergency. Request that a second emergency apparatus access road be installed to allow egress from the lots in case of an emergency as required in the IFC 2018 section 503.1.3 Additional access.

16. Because of the limited access, the presence of the pipeline and the location of the development. I recommend that the new homes within East Goshen Township be sprinklered as required in West Whiteland Township.
PENDING - East Goshen Township Fire Marshal is asking the Board of Supervisors that the new dwellings shall have a residential sprinkler system installed.

Please note that driveways are required to meet the IFC 2018 code requirements for fire apparatus access roads. Specifically, sections 503.2.5 Dead Ends, 503.2.3 Surface, 503.2.1 Dimensions, and 503.2.7 Grade.

A RESOLUTION OF THE BOARD OF SUPERVISORS OF EAST GOSHEN TOWNSHIP AUTHORIZING THE TOWNSHIP TO ENTER INTO AN INTERGOVERNMENTAL COOPERATION AGREEMENT WITH WEST WHITELAND TOWNSHIP TO COORDINATE GOVERNMENTAL SERVICES PROVIDED TO SIXTEEN (16) PARCELS LOCATED ON A PRIVATE CUL DE SAC TO BE KNOWN AS ZERMATT STATION ROAD, AND ENTITLEMENT OF RATES AND CHARGES RESULTING THEREFROM.

WHEREAS, East Goshen Township and West Whiteland Township (collectively the "Townships") desire to enter into an Intergovernmental Cooperation Agreement to coordinate governmental services to be provided to the sixteen (16) parcels created by a Final Subdivision and Land Development Plan (the "Subdivision Plan") for 1375 Old Phoenixville Pike and 1338 Morstein Road (the "Development"), and entitlement to collection rates and charges; and

WHEREAS, the Development is intersected by the border between the Townships; and

WHEREAS, the length of the proposed cul de sac, to be known as Zermatt Station Road, is largely located within West Whiteland Township, with thirteen (13) of the proposed parcels within the municipal boundary of West Whiteland Township, and three (3) parcels surrounding the termination of the road within East Goshen Township; and

WHEREAS, the Townships desire to coordinate governmental services provided to the three (3) lots located within East Goshen Township as outlined in the Agreement; and

WHEREAS, pursuant to 53 Pa.C.S. § 2305, (the "Intergovernmental Cooperation Act"), two or more municipalities of the Commonwealth may jointly cooperate in the exercise and performance of their respective governmental functions, powers or responsibilities and may effectuate such cooperation by entering into and executing a joint agreement for such purposes; and

WHEREAS, Section 1507 of the Second Class Township Code, 53 P.S. § 66507, authorizes the Board of Supervisors of a second class township to make agreements with other municipal corporations in performing governmental powers, duties and functions and in carrying into effect provisions of the Intergovernmental Cooperation Act; and

WHEREAS, the respective governing body desires to adopt this Resolution to approve the attached Intergovernmental Cooperation Agreement and authorize its execution.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of East Goshen Township hereby resolves as follows, incorporating the above recitals by reference:

SECTION 1. Terms of Cooperation Agreement. A true and correct copy of the Intergovernmental Cooperation Agreement is attached hereto as Exhibit "A." The conditions of participation, purpose and objectives of the Agreement as set forth in Exhibit "A" are incorporated by reference as if set forth fully at length herein.

<u>SECTION 2.</u> Authorization to Execute. That the appropriate officers are hereby authorized to execute the Intergovernmental Cooperation Agreement, as well as any other documents necessary to carry out its intent and purpose, on behalf of the Township, respectively.

SECTION 3. Repealer. Any other previous Resolutions that are inconsistent herewith are repealed to the extent inconsistent herewith.

AND NOW, at a duly advertised public meeting held the 2nd day of September 2025, upon motion duly made and seconded, the foregoing **RESOLUTION** is hereby adopted.

INTERMUNICIPAL AGREEMENT

THIS INTERMUNICIPAL AGREEMENT, made this day of
20, by and among the Commonwealth of Pennsylvania municipalities of West Whiteland
Township and East Goshen Township (collectively, the "Municipalities" of "Parties").

BACKGROUND

WHEREAS, West Whiteland Township, Chester County, Pennsylvania (hereinafter "West Whiteland") is a Second-Class Township with an official address of 101 Commerce Drive, Exton, Pennsylvania;

WHEREAS, East Goshen Township, Chester County, Pennsylvania (hereinafter "East Goshen") is a Second-Class Township with an official address of 1580 Paoli Pike, West Chester, Pennsylvania;

WHEREAS, a Final Subdivision & Land Development Plan (the "Subdivision Plan") has been approved by the Municipalities for 1375 Old Phoenixville Pike and 1338 Morstein Road (the "Development");

WHEREAS, the Subdivision Plan is attached hereto as Exhibit "A".

WHEREAS, the Development is intersected by the border between West Whiteland and East Goshen;

WHEREAS, the Development consists of sixteen (16) single-family residential dwellings, of which thirteen (13) single family detached residential lots are located in West Whiteland and three (3) such lots are located in East Goshen;

WHEREAS, the three (3) residential lots located in East Goshen are Lots 6, 7, and 8 as shown on the Subdivision Plan ("East Goshen Lots");

WHEREAS, access to the Development is from Old Phoenixville Pike, by way of Zermatt Station Road which is the to be constructed cul de sac as shown on the Subdivision Plan;

WHEREAS, the length of Zermatt Station Road is largely located within West Whiteland but the road terminates in East Goshen;

WHEREAS, Zermatt Station Road is a private road and shall be maintained by the residents and/or the governing Association of the Development;

WHEREAS, neither East Goshen nor West Whiteland shall have any maintenance obligations pertaining to Zermatt Station Road;

WHEREAS, the Municipalities recognize that fire response and police response are received, prioritized, and dispatched through other departments, services, and mechanisms;

WHEREAS, the Municipalities desire to coordinate sewer and trash services for the Development;

WHEREAS, West Whiteland has agreed to allow connection of all homes in the Development including, the East Goshen Lots, to West Whiteland's grinder pumps and force main;

WHEREAS, West Whiteland has agreed to provide municipal trash removal services for all homes in the Development including, the East Goshen Lots; and

NOW, THEREFORE, the Parties hereto, in consideration of the mutual promises set forth herein and for other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Municipalities agree as follows:

- 1. <u>Incorporation of Recitals.</u> The recitals set forth in the Background section of this Agreement, as well as the Exhibits hereto, incorporated herein as if set forth below in their entirety.
- 2. <u>Mutual Cooperation</u>. The Municipalities agree to execute all documents and take all action necessary to effectuate the terms and conditions of this Agreement.
- 3. <u>Imposition of Sewer Rates and Charges</u>. The Municipalities agree that West Whiteland shall impose sewer rates or charges upon owners of the East Goshen Lots that shall be connected to its Sanitary Sewer system for use thereof, which thereafter, will be imposed or maintained by ordinance or resolution.
- 4. <u>Imposition of Municipal Trash Collection Rates and Charges</u>. The Municipalities agree that West Whiteland shall impose trash collection rates or charges upon owners of East Goshen Lots that shall be serviced by West Whiteland's municipal trash removal services, which thereafter, will be imposed or maintained by ordinance or resolution.
- 5. <u>Fire and Police Response</u>. To the extent that a dispute arises as to which Municipality shall provide the fire or police response to the Development, West Whiteland shall

provide fire and police response services to all homes in the Development. This provision shall not be construed to take priority over any mechanism already in place which provides for dispatch of fire and police services and/or any method already in place for determining any compensation between the Municipalities for fire and police services.

6. Miscellaneous.

- a. West Whiteland shall direct that the appropriate staff and third-party professionals carry out this Agreement as set forth herein.
- b. Any costs incurred prior to the execution of this Agreement shall be borne by each municipality.
- c. This Agreement shall be construed in accordance with the laws of the Commonwealth of Pennsylvania, excluding any statutes or rules regarding conflicting laws.
- d. This Agreement and any Exhibits, incorporated herein, represent the entire agreement of the Parties hereto, and there are no collateral or oral agreements or understandings. This Agreement may be amended or modified only in writing signed by the Municipalities.
- e. This Agreement may be executed in counterpart, each counterpart shall constitute an original, but all of which together shall constitute one and the same agreement. Each counterpart agreement that is signed by a party shall indicate the date that the counterpart was approved and signed.

We have been discussing the budget since our September 2nd meeting. The proposed 2026 budget continues to be on the "Finance" page of our website and readily available for anyone interested.

As of now, this is the last scheduled board meeting before our November 18th meeting, which would be the meeting we would be looking for a possible adoption of the 2026 Preliminary Budget and then, subsequently, the passage of the Final Budget in December.

At this point we are narrowing our focus specifically on the outstanding items with regard to funding allocation (mostly first responder-related) as well as a discussion on some variances we are looking at from the initial September meeting versus currently.

However, as always, Dave and I are open to discussing any and all aspects of the proposed 2026 budget as the board sees fit.
