Call to Order

Dan called the meeting to order at 7:00 p.m.

Pledge of Allegiance & Moment of Silence

Dan led those present in the Pledge of Allegiance and then asked for a moment of silence to remember our police, EMTs, and Military.

Approval of Minutes

The minutes of the November 12, 2025 meeting were approved as amended.

Chairman's Report -

1. Dan introduced Jeff Bryer of Bryer Apiary (447 Reservoir Rd) who will speak on the state of honey bees in East Goshen. Here are some of the facts Jeff gave:

- 1/3 of our food supply is pollinated by honey bees
- Bees are taken out to California for a few weeks to pollinate almond trees
- Pesticides and chemicals are dangerous to bees. Farmers spray their crops with Roundup.
- Neonicks insecticides are very bad for many living things. They are used in lawn chemicals.
- Bees like native plants. Dandelions are good for bees.

1 • Honey bees are from Europe. They arrived about 400 years ago. His bees are
2 Italian.
3 • There are about 4,000 native bee species.
4 • Water is important to honey bees. They prefer water in pools, on streets, etc.
5 • Colony Collapse Disorder - In about 2006 a PA bee keeper was the first to
6 discover this in the USA. Jeff lost 50% of his bees to this disorder. It is caused by mites that
7 carry viruses. CCD is worldwide. There is a treatment now that effects the mites.
8 • The Chester County Bee Keepers Assoc. has 625 members and there are probably
9 a lot more that don't belong. Jeff has 45 hives. This year the spring rain effected the amount
10 of honey.
11 • Swarms can be hanging from anywhere. If you see one call a bee keeper.
12 • The bees cover about 27 sq. miles around their hive. Plant pollinator friendly
13 plants. Don't use herbicides or insecticides on your lawn. Native bees are on the decline so
14 planting good plants helps.
15 Peg mentioned that there are 437 native bees in PA. Doug Tallamy does a presentation on
16 what he does in his backyard. Read his book.
17 Dan thanked Jeff for his presentation.

19 **New Business -**

20 **1. Invasive species on Township Open Space -** Richard Hankin and Ada Brainsky of 713
21 Jamestown Way (Clocktower) - Dan introduced Mr. Hankin and explained that he has done
22 a lot of work on his property because he is concerned about invasive plants in the Township
23 open space that his property backs up onto. Mr. Hankin explained that he planted native
24 plants on his property because his property goes into the woods and he noticed invasive
25 plants are taking over the woods. Ada described the invasive plants and trees, such as Ash,
26 that have reduced the canopy of the woods. She suggested growing native trees to make a
27 good canopy. Richard walked the Ashbridge Preserve where the Conservancy has planted
28 trees. He has planted many plants and tress to repair the canopy. Peg mentioned that she
29 just worked with Malvern to remove some invasives. They had about 50 kids from Malvern
30 Prep to help pull out the invasives. The CRC was going to plant about 50 trees and shrubs
31 where the invasives were cleared. They had a grant to help pay for it. Dan explained that
32 the CB has been working on planting trees on the riparian buffers along the waterways.
33 Ashely will ask Mark Miller to look at this. Mr. Hankin mentioned that Mark Miller was
34 there in the Spring.

37 **Old Business**

38 **1. PECO Arbor Day-** Arbor Day will be Friday, April 24, 2026. Chester County and East
39 Goshen has been asked to host this event. PECO will donate 100 trees. Some will be given
40 away for free. Ashley spoke with a PECO rep who will contact her closer to April 24th.

42 **2. Collaboration with ESAC -** Julie mentioned that she spoke with Ken Flanagan of ESAC
43 about a collaboration meeting. Ashley recommended having members of the group attend
44 the regular monthly meetings instead of a separate meeting. She feels they will have to
45 advertise a separate workshop.

47 **3. Fall Planting -** This will probably be a spring planting. There is only \$750.00 left in the
48 CB budget. There was discussion about jumping worms!

50 **4. Communication -** Dan mentioned that the Instagram on yard racking was good. Karen
51 wrote it.
