## **Chairperson's Report**

Gerry summarized an article he read that described a newly patented carbon capture technology. A material, which is highly effective at absorbing carbon dioxide from the air, is synthesized from spent coffee grounds and plastic waste. The environmental benefits of this invention are huge.

## **Old Business**

### **Update on formal request to PennDOT for guard railing on Paoli Pike at the Williams natural gas valve station**

Derek shared that PennDOT denied our formal request for this guard railing. He suggested contacting Williams to inquire about providing extra protection at this valve station. He also suggested contacting the property owner to determine if they would be amenable to having additional safety measures installed on their land. The PTF would like to appeal this decision by PennDOT. Gerry will work on drafting a response letter to PennDOT from the township. Our local legislators will be copied. Mary will make the initial contact with them.

### **Results of Chester County Pipeline Incident Full Scale Exercise on 10/27/2025**

Judi and Gerry observed this exercise. It was very interesting and highly informative. They provided feedback to the Chester County Department of Emergency Services, who organized the exercise. Kennan commented on the potential ignition sources during a pipeline leak.

### **Update on Chester County Emergency Planning – EGT Pipeline Incident Annex**

The township is waiting for this annex. The PTF will provide input once it is received. The BOS will then need to review and approve it.

### **Plans to invite local legislators to future PTF meetings**

Mary has reached out to our local legislators. Representative Pielli agreed to attend. He will talk with Representative Howard and Senator Comitta.

## **New Business**

### **Proposed carbon dioxide pipeline in Louisiana**

Gerry summarized an article he read regarding a new carbon dioxide pipeline that Exxon is proposing. It would be located in a residential area in Louisiana. The distances from nearby businesses and homes are significantly less than those described in the EGT ordinance on Carbon Dioxide Transmission Pipelines.

### **PTF article for next township newsletter**

The group discussed possible topics for the next newsletter. Given the current schedule, we can work on this at our meetings early next year. [PMN: The newsletter deadline has been moved up. Therefore, this article will need to be finalized at our next meeting.]

**PTF meeting schedule for 2026**
