All-Terrain Crawler Carrier Utility Machines Rental:

- 1) Two rentals needed
- 2) Rubber tracks not required
- 3) Carrying capacity: 28,000lbs
- 4) 320hp; 1800rpm

Chemicals:

- 1) 14,000 gallons of aluminum sulfate, 50% low iron
***Must be delivered in a straight tank truck, NO TRAILERS**
- 2) 20,000 gallons of caustic soda (25% sodium hydroxide) in liquid bulk delivery

Crusher: Rubble Master RM70GO or comparable

Fuel:

- 1) 2,000 gallons: 89 octane unleaded gasoline

Milling Machines Without Operators (two):

- 1) 1.3-meter-wide milling drum. Shall be capable of milling next to vertical curb. Milling depth shall be adjustable from a minimum of 0.0 inches to 12.0 inches.
- 2) Milling machine will have a 7' x 2" wide milling head with a self-loading conveyor. The milling machine shall have a front-loading conveyor. The conveyor shall be covered and shall be capable of loading a dump truck that has a tail gate height of 12 feet. The milling machine shall be equipped with a water system for dust control.

- A) All signs shall be PA DOT-approved.
- B) All signs to be pre-punched for mounting.
- C) All signs to be constructed with hi-intensity sheeting.
- D) General:
 - 1) Performance bond or certified check for 50% of the grand total price must be supplied within 30 days after notification of the award of the contract.
 - 2) All hardware to be supplied with breakaway posts.
 - 3) Unit prices to include all shipping and delivery charges.
 - 4) All items shall be delivered to East Goshen Township, 1580 Paoli Pike, West Chester, PA 19380.
 - 5) All quantities are estimated.
 - 6) **Bidders must bid all items.**
 - 7) **Signs and posts must be delivered to the East Goshen Township building within thirty (30) calendar days from the date the order is placed.** It is understood that the timely replacement of damaged and defaced signs is a matter of serious and vital concern to the Township because of the effect which it has upon the safety of motorists. It is anticipated that occasional minor breaches of the delivery requirement may occur during the course of the performance of the contract. Since the cost of these minor breaches are incapable of prompt and reasonable calculation, the Township Manager may invoke the following stipulated liquidated damages on behalf of the Township. This determination and certification of the same shall be final if signs and posts are not delivered to the East Goshen Township building within fifteen (15) days of placement of the order.
 - (31) **First offense:** A written warning will be sent to the contractor.
 - (32) **Second through fifth offense:** The price paid shall for the order shall be reduced by ten (10) percent.
 - (33) **Sixth offense:** Contract will be terminated for non-performance.
 - (34) Any damages assessed for any of the aforesaid violations shall be deducted from the next payment due to the Contractor.

The contractor hereby proposes and agrees.

- To provide on a rental basis equipment described in the attached Schedule of Equipment on an as needed basis, where directed, within the geographic area described in the Schedule of Equipment for a period beginning January 1, 2027, and ending on December 31, 2027.
- To maintain this equipment in good mechanical and operating condition and to make all repairs and / or replacements at the CONTRACTORS expense.
- The equipment described in the Schedule of Equipment shall be provided to the MUNICIPALITY upon three (3) days oral notice for all its operations, except snow removal operations, for which purpose the equipment will be provided with two (2) hours notice of oral notification.
- To furnish all fuel, anti-freeze, operator(s) and necessary operating attachments.
- The CONTRACTOR shall permit the MUNICIPALITY to review all records relating to labor and equipment utilized under the terms of this agreement.
- The CONTRACTOR shall provide adequate insurance coverage in the form of Property Damage and Bodily Injury Insurance. If required by the MUNICIPALITY, evidence of such coverage, in the form of a certificate of a qualified insurance company, must be provided when the CONTRACTOR is notified by MUNICIPALITY that his bid has been accepted.
- The CONTRACTOR is responsible for all costs incurred in the delivery and return of the equipment.
- When accepted by the MUNICIPALITY, this proposal will constitute a contract binding on the CONTRACTOR, their executors, administrators, successors or assignees.
- Accompanying this proposal is a certified check or bid bond payable to the MUNICIPALITY in the amount of N/A, as a proposal guarantee which, it is understood, will be forfeited in the event the CONTRACTOR is awarded the contract and fails to provide the necessary performance bond, as required in Paragraph 10.

The successful bidder shall, within 30 days of the award of the contract, submit a guarantee of performance of the terms of the contract in the form of a bond or certified check payable to the MUNICIPALITY in the amount of 50% of bid. If a certified check is submitted, it will be forfeited to the MUNICIPALITY to cover any added costs to the MUNICIPALITY in the event it determines by written notice to the CONTRACTOR that any equipment was not available when needed or that its performance was unsatisfactory.
